

Brief Details of the Treatment facility

The various wastage are segregated at the point of generation and kept in color coded bins with bio-degradable bags containing bleaching solution and presence of supervisor and finally shifted to the containment area store room and these items are shifted by an outsourcing agency name "M/s Mediaid Marketing Service, Corporate Office at 703, 7th Floor, Utkal Signature, Pahal, Bhubaneswar-752101, Odisha" selected by the CDM & PHO, Keonjhar for shifting the waste within 48-hours.

The mutilated plastics which are kept in blue bins in bleaching solution are kept in a closed area to be shifted to outsourcing agency.
